


► A special Synod

Synod 2026 was very special, as this year we celebrate the 50th Anniversary of our Diocese - our Jubilee. Recent Synods have taken place in Larnaca, Cyprus. This was our first time in Bahrain and a lot of hard work had gone into making this Synod as interesting, useful and productive as possible - and to make the best use of our time together as a Diocese.



It was a joyous, uplifting occasion, with a palpable feeling of unity, fellowship and prayerful support for one another. The welcome and hospitality we received from the congregations and clergy of St Christopher's Cathedral and from Awali Church (the Tamil-speaking congregation further South on the island) was truly warm and generous.

► Our Diocese - who are we and where are we all from?

Synod comprises roughly 100 people (about 50 delegates and up to 50 visitors).


Our Diocese has

- 2 parishes in Northern Cyprus
- 6 parishes in the Republic of Cyprus
- A parish in Baghdad
- A parish in Kuwait
- A parish in Bahrain
- A parish in Qatar
- 5 parishes in the UAE
- A parish in Oman
- A parish in Yemen (Christ Church, Aden - not currently operating as a church, but running a hospital, run by local medical staff)



Almost all parishes in the Diocese send clergy and up to two lay delegates.

We are the second largest (by geographical area) and probably the most diverse diocese in the Anglican Communion. Over 60% of the people in our diocese speak Tamil as their first language, but scores of other languages are also spoken. Some Gulf churches are growing rapidly, as increasing numbers of people go there to work.

► What happened at Synod ?

Synod took place 2nd - 6th February over 3 full days and parts of 2 days.

Every day was different, but there was also something of a pattern.

- There was a Eucharist every day, together with other services.
Each day ended with Compline (Night prayer).
- The Synod Speaker gave an address on the 3 full days, followed by workshops on 2 of them
- The House of Laity and House of Clergy held their own meetings at the start and end of Synod.
- Synod Sessions took place on each of the 3 full days.
These were very busy sessions, where the 'business' part of Synod happened.

In addition, there were outside visits and optional activities.

Many guests brought greetings from their churches or organisations and some gave reports.

Guests to Synod included Bishop Julius Wanyoike from our sister Diocese of Thika (in Kenya) and Bishop Moira Astin (Bishop of Crediton) from our sister Diocese of Kent.

The Reverend Don Binder (Chaplain to Archbishop Hosam) and The Venerable Fuad Dagher, from Galilee, representing of the Diocese of Jerusalem & the Province of Jerusalem and the Middle East, were collated as Provincial Canons of St Christopher's Cathedral, Bahrain.

In the same service, Rev'd Canon Walter Brownridge was licensed as Dean of St Paul's, Nicosia and Rev'd Navina Thompson was licensed as parish priest of St Helena, Larnaca.

► House of Laity Meetings

The House of Laity (HoL) is an extremely important body in the Diocese and is made up of all of the **Lay Delegates** to Synod, who represent the people in the pews.

Diocesan committees and working groups include lay delegates, who are elected by the House of Laity. They often bring invaluable experience and expertise from areas outside of the Church, together with a fresh perspective. It is important for the Diocese to be able to draw on the skills of a wide variety of lay people and for individuals to be in a position to contribute to the life and work of the Diocese.

► Synod Sessions

All of the Synod Sessions - when reports are received, questions asked and motions passed - took place in the main conference hall.

Each delegation sits together in allocated seats, with their parish name card in front of them. Parishes are arranged alphabetically.

The main conference hall is arranged so that all delegates can see one another.

Members of the Standing and Finance Committee (SFC) sit at the 'top' table and, between them, they chair all of the sessions (SFC is the Bishop, Archdeacons, 2 clergy and 2 laity - *Further information on the SFC is included at the end of this guide*).

Parish delegations are arranged around the other 3 sides, so that everyone is looking inwards, at one another. Visitors (who do not have a vote) are all outside of this square.

► Key decisions made at Synod 2026

The Bishop's Task Force, set up by Synod 2025, had considered possible models of Diocesan organisational structure, better suited to the challenges and opportunities faced as it enters its second half-century.

The Task Force brought proposals to Synod, all of which were agreed.

Archdeaconries

Synod approved the creation of:

- an Archdeaconry of Northern Arabia consisting of the parishes in the countries of Bahrain, Iraq, Kuwait and Qatar, and the central territories of the Arabian Peninsula
- an Archdeaconry of Southern Arabia consisting of the parishes of the countries of the UAE, Oman and Yemen.

The Bishop's Office and Residence will remain in the Republic of Cyprus for the next five years but this matter will be re-examined in 2030.

The Archdeaconry of Cyprus will be retained, with an Archdeacon serving the (current) 8 parishes of the divided island.

The geographic extent, complexity and number of parishes (approximately 12) in the current Archdeaconry of the Gulf place unrealistic demands on the Archdeacon in the Gulf. The restructuring of the Archdeaconry of the Gulf will result in a more manageable and efficient archidiaconal ministry.

There is currently not the financial means to fund full-time Archdeacons (i.e. Archdeacons who have no parish responsibilities) - a role currently undertaken in addition to a full-time parish role, under the terms of a three-year agreement with the relevant parish.

Cathedrals & Deans

Synod agreed that:

A church may be designated a Cathedral by recommendation of the Bishop and with the support of the church in question and a majority of Synod.

A Cathedral can be returned to the status of Parish Church by writ of the Bishop with the majority support of Synod, and after consultation with the Dean and Cathedral Council.

A candidate for Dean will be required to have a minimum of 10 years in Holy Orders.

A Dean is, in the first instance, the parish priest of the Cathedral parish.

Deans will rank as the most senior priests of the Diocese.

Deans will alternate each Synodical year as the Vicar General of the Diocese, representing the Bishop in Administrative and Pastoral matters as directed or required through episcopal vacancy, sabbatical or incapacity.

Deans will be members of the Standing and Finance Committee.

Each Cathedral of the Diocese will have a College of Honorary Canons, selected for their modelling of exceptional ministry and service in or for the Diocese or for their potential to contribute to the ongoing mission of the Diocese and Cathedral.

The Chair of the College of Canons will be the Dean of the Cathedral, and the College will meet at least annually. The College of Canons will act in an advisory and supportive role to the Dean and Cathedral, with authority for decision-making reserved entirely for the Cathedral Council.

Archdeaconry Forums and Councils

Synod agreed the formation of **Archdeaconry Forums**, to which all Archdeaconry licensed and PtO clergy and members of parish electoral rolls are invited. Their role will be to offer input on Diocesan and parish issues between and in support of meetings of Synod.

The formation of **Archdeaconry Councils** was also agreed, consisting of two members of the House of Clergy and two members of the House of Laity from the relevant Archdeaconry, to assist in the governance of that Archdeaconry with particular regard to HR and legal issues.

► Constitution & Standing Orders

The Constitution is simply a document that explains the purpose of an organisation, how it is set up and how it goes about what it is set up to do.

A copy of the Diocesan Constitution can be found on the Diocesan website.

The Standing Orders for the Diocesan Synod outline how Synod should be run.

Key points regarding Synod

The **Constitution** is made up of:

- A preface, which explains what the Diocese is
- 4 chapters, divided into 18 articles (sections)

The **Standing Orders for the Diocesan Synod** comprise: 99 Standing Orders organised into 21 sections (*Standing orders are detailed rules for how meetings are organised and run*)

CHAPTER 2 of the Constitution. Governance of the Diocese includes sections on:

- The Diocesan Synod
- The Standing and Finance Committee (SFC)

FROM CHAPTER 2. The Diocesan Synod:

- Must meet at least once a year
- Is made up of:
 - The House of Bishops - Diocesan Bishop (and any Suffragan or Assistant Bishops)
 - The House of Clergy - All priests and Deacons licensed under Seal in the Diocese, plus some non-voting members
 - The House of Laity - Two representatives from each parish, plus the lay members of the Standing and Finance Committee

A Chair of the House of Clergy is elected by its members to serve a 3 year term

Two Chairs of the House of Laity (one each from the Gulf & from Cyprus) are elected by its members to serve a 3 year term.

Members of the HoL are elected annually by their parishes.

- **Synod has authority on all matters relating to the Diocese except**
 - Matters relating to Faith and Order
 - Matters under the jurisdiction of the Provincial Synod
 - The appointment of Clergy
- **Synod has powers to:**
 - Advise the Bishop
 - Express opinion on matters referred to it by the Provincial Synod
 - Open and administer institutions (schools, hospitals, etc)
 - Set up boards and committees
 - Receive, amend, approve or reject recommendations of the Standing and Finance Committee
 - Appoint legal advisors
 - Make, amend and revoke Standing Orders
- **The Standing and Finance Committee (SFC)**
 - This is the Executive Committee of the Synod
 - It reports to Synod
 - The SFC considers matters arising and takes action where necessary when Synod is not on session
 - The Bishop consults the SFC on all important matters
 - It raises matters of concern with the Bishop
 - The SFC prepares the agenda for Synod
